# **How to Read Factsheet**

**Fund Manager:** An employee of the asset management company such as a mutual fund or life insurer, who manages investments of the scheme. He/She is usually part of a larger team of fund managers and research analysts.

**Application Amount for Fresh Subscription:** This is the minimum investment amount for a new investor in a mutual fund scheme.

**Minimum Additional Amount**: This is the minimum investment amount for an existing investor in a mutual fund scheme.

SIP: Systematic Investment Plan (SIP) works on the principle of making periodic investments of a fixed sum. It works similar to a recurring bank deposit. For instance, an investor may opt for a SIP that invests ₹500 on every 15th of a month in an equity fund for a period of three years.

**NAV:** The NAV or the net asset value is the total asset value per unit of the mutual fund after deducting all related and permissible expenses. The NAV is calculated at the end of every business day. It is the value at which an investor enters or exits the mutual fund.

**Benchmark:** A group of securities, usually a market index, whose performance is used as a standard or benchmark to measure investment performance of mutual funds. Some typical benchmarks include the NIFTY, Sensex, BSE200, NSE500, Crisil Liquid Fund Index and 10-Year Gsec.

Entry Load: A mutual fund may have a sales charge or load at the time of entry and/or exit to compensate the distributor/agent. Entry load is charged when an investor purchases the units of a mutual fund. The entry load is added to the prevailing NAV at the time of investment. For instance, if the NAV is ₹100 and the entry load is 1%, the investor will enter the fund at ₹101.

**Note:** SEBI, vide circular dated June 30, 2009 has abolished entry load and mandated that the upfront commission to distributors will be paid by the investor directly to the distributor, based on his assessment of various factors including the service rendered by the distributor.

Exit Load: Exit load is charged when an investor redeems the units of a mutual fund. The exit load is reduced from the prevailing NAV at the time of redemption. The investor will receive redemption proceeds at net value of NAV less Exit Load. For instance, if the NAV is ₹100 and the exit load is 1%, the investor will receive ₹99 per unit.

**Modified Duration:** Modified duration is the price sensitivity and the percentage change in price for a unit change in yield.

**Average Maturity:** The average time of maturity of all the debt securities held in a portfolio. It states the weighted average maturity of the assets in the portfolio.

**Yield to Maturity (YTM):** The Yield to Maturity or the YTM is the rate of return anticipated on a bond is held until maturity. YTM is expressed as an annual rate. The YTM factors in the bond's current market price, par value, coupon interest rate and time to maturity.

**Standard Deviation:** Standard deviation is a statistical measure of the range of an investment's performance. When a mutual fund has a high standard deviation, it means its range of performance is wide, implying greater volatility.

**Macaulay duration**: The Macaulay duration is the weighted average term to maturity of the cash flows from a bond. The weight of each cash flow is determined by dividing the present value of the cash flow by the price

**Sharpe Ratio:** The Sharpe Ratio, named after its founder, the Nobel Laureate William Sharpe, is a measure of risk-adjusted returns. It is calculated using standard deviation and excess return to determine reward per unit of risk.

**Beta Ratio (Portfolio Beta):** Beta is a measure of an investment's volatility vis-a-vis the market. Beta of less than 1 means that the security will be less volatile than the market. A beta of greater than 1 implies that the security's price will be more volatile than the market.

**AUM:** AUM or assets under management refers to the recent/ updated cumulative market value of investments managed by a mutual fund or any investment firm.

**Holdings:** The holdings or the portfolio is a mutual fund's latest or updated reported statement of investments/securities. These are usually displayed in terms of percentage to net assets or the rupee value or both. The objective is to give investors an idea of where their money is being invested by the fund manager.

Nature of Scheme: The investment objective and underlying investments determine the nature of the mutual fund scheme. For instance, a mutual fund that aims at generating capital appreciation by investing in stock markets is termed an equity fund or growth fund. Likewise, a mutual fund that aims at capital preservation by investing in debt markets is a debt fund or income fund. Each of these categories may have sub-categories.

Rating Profile: Mutual funds invest in securities after evaluating their creditworthiness as disclosed by the ratings. A depiction of the mutual fund in various investments based on their ratings becomes the rating profile of the fund. Typically, this is a feature of debt funds.

**Total Expense Ratio:** Total expenses charged to scheme for the month expressed as a percentage to average monthly net assets.

**Portfolio Turnover Ratio:** Portfolio Turnover Ratio is the percentage of a fund's holdings that have changed in a given year. This ratio measures the fund's trading activity, which is computed by taking the lesser of purchases or sales and dividing by average monthly net assets.

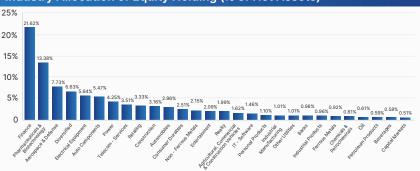

# Samco Active Momentum Fund

## **Portfolio Comment for August 2024**

The month of August 2024 was market by heightened volatility in the Indian and Global equity markets. The markets witnessed a sharp selloff in the beginning of the month due to the unexpected rate hike by the Bank of Japan leading to the unwinding of the "yen carry trade" leading to panic selling across various world markets including Indian stock markets. However, as the global markets settled, the Indian equity markets climbed the wall of worry. The markets registered fresh lifetime highs with strength across different market segments. The headline index Nifty 50 gained around 1.14% during the month. The Nifty 100 and Nifty Midcap 150 indices gained 0.83% and 0.30% respectively. As evident in the recent past, the Smallcap 250 gained the most with a change of 1.14% on a monthly basis.

The Indian equity markets are sustaining robust momentum backed by solid fundamentals of the Indian economy both on relative and absolute basis as well as the strong liquidity with the domestic institutions in the country. True to its strategy, your fund is focused on identifying the strongest segments in the market and aligning the portfolio to these areas to generate superior risk adjusted returns. The nature of the fund provides the flexibility to hedge the portfolio in case of a market downturn to protect the downside risk of the capital deployed. The recent comments by the Fed chief could be a signal towards big shifts in the global markets: As history suggests, in case of a panic rate cut by the Fed the global markets could witness a sharp selloff. Thus, we are cautiously optimistic on the Indian equity markets backed by the positive domestic factors but a fragile global economic scenario.

As of August 31, 2024, we have deployed 98.58% of net assets in Indian Equities, with the remaining 1.42% allocated to TREPS, Cash, Cash Equivalents, and Net Current Assets.

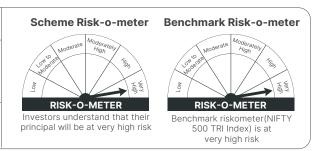

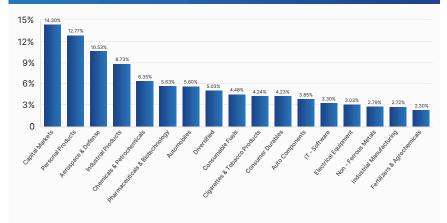

# Samco Flexi Cap Fund

## **Portfolio Comment for August 2024**

We have deployed 99.88% of our AUM in Indian Equities and 0.12% in TREPS, Cash, Cash Equivalents, and Net Current Assets as of August 31, 2024.

August has been a strong month for the markets, showing no signs of slowing down. The upward momentum continues, with indices reaching new highs. Our flexi cap fund has allowed us to leverage diversification across multiple market caps to benefit from this trend. However, we are closely monitoring macroeconomic and microeconomic factors, as well as valuations. At the first indication of a broader downturn, we will swiftly adjust our allocations.

While the quality of our businesses remains solid, we have made some notable adjustments to the portfolio this month. We have significantly increased our exposure to the personal products sector and added holdings in fertilizers and agrochemicals. Conversely, we have reduced our stake in industrial products, capital markets & non-ferrous metals and fully exited from minerals and mining. Through this reallocation, we aim to effectively navigate potential challenges in certain sectors.

Our portfolio management strategy remains focused on quality, prioritizing well-capitalized, resilient businesses. We continue to adhere to this disciplined approach, even amidst the market's volatility, which will help safeguard our portfolio if and when market conditions change.

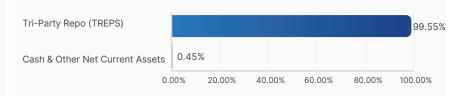

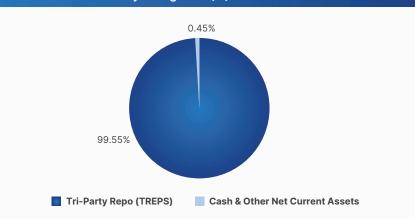
